# 2 Report summary

# 2.1 Situation

The following updates have been received for the August Corporate Risk Register Risk assessment 006 relating to - No formal arrangements for professional direction or clinical consultant report for Laboratory services

The risk rating is likelihood equalling expected to recur, with a consequence of major.

The Blood Transfusion service is now a hub & spoke with Scottish National Blood Transfusion Service (SnBTS) based at Gartnavel Hospital.

The clinical lab service does not have an agreement for support and advice with a larger mainland service. Discussions with NHS Highland have been unsuccessful, and the new national laboratory information Management System (LiMS) system work stream will bring us in line with many other areas of Scotland (but not Highland). The current state places significant burden on the Lab Manager and specialist BMS staff. A satisfactory solution is not available in the immediate future, but the LiMS work stream will facilitate closer working with our central belt & west coast mainland colleagues.

Risk assessment 002A relating to Civil Contingencies Business Continuity

This risk assessment has been updated and reviewed. There have been very minor changes added to the risk assessment and the risk rating remains the same. Due to the cost versus benefits this is an accepted risk which is reviewed 6 monthly.

Risk assessment 002B relating to Civil Contingencies Major Incident Response.

This risk assessment has been reviewed and updated. There have been minor changes added to the risk assessment and the risk rating remains the same. Pandemic influenza is on hold as the national risk has been suspended until after the COVID Pandemic to allow a complete rewrite. As our risk assessment is based on this an upgrade cannot be completed at present.

Risk assessment 039 relating to Unscheduled care of Children and Neonates. This risk assessment is to be archived as NHS Western Isles now employs consultant paediatrician 24/7.

NHS@ Western Isles Hospital continues to up skill non medical staff in paediatric care (emergency and routine inpatient).
