2 Report summary

2.1 Situation

This is version 4 draft 3 of the Framework for Adverse Event Reporting, Managing and Learning.

The following changes have been made to draft 2 of the document:

- Page 4 relating to the scope of the document. Added that the Framework covers all adverse events reported in NHS Western Isles.
- Page 8 All references to the Operational and Single Operating Division Management Teams have been removed and replaced with Operation Service Delivery Team.

- Page 10 Section 3.2 Identification and immediate actions following an adverse event. Added in staff impacted or potentially harmed by work activities.
- Page 15 Section 3.5 Review and analysis. Consideration of the wider organisational factors added and statement relating to staff only removed.

Other suggestions relating to a specific investigation process for adverse events and specific investigation competence framework will be included in our operational procedures, as these 2 topics are currently being discussed at Health Improvement Scotland and the Adverse Events Network.

The Framework for Adverse Event Reporting, Managing and Learning from Adverse Events once approved will not be finally published until the terms of reference for the Operational Service Delivery Team have been agreed.

2.2 Background

The draft Adverse Event Framework for Reporting, Management and Learning has been developed in line with the Health Improvement Scotland learning from adverse events through reporting and review (A national framework for Scotland December 2019 and 2021).

Version 4 draft 2 has previously been to CMT and Healthcare Governance and Audit Committee meetings. Following feedback from the HCG&A meeting the draft document has been reviewed and updated to include the comments received.

2.3 Assessment

The Framework has been developed following the 6 stages of managing an adverse event in the National Framework for Scotland. (2019/ and 2021)

Feedback received on draft 1 and draft 2 of the Framework have been included in draft 3.

2.3.1 Quality/ Patient Care

The Framework will support staff to manage adverse events within the agreed timescales and involve patients, families and carers.

2.3.2 Workforce

The Framework and supporting documents will be a resource for staff to report, manage and learn from adverse events.

2.3.3 Financial

There is no financial impact with the development and implementation of the Framework

2.3.4 Risk Assessment/Management

There are no risk assessments to accompany the Framework.

2.3.5 Equality and Diversity, including health inequalities

An impact assessment has not been completed as advised that it is not required.
