# 2.1 Situation

The report provides a summary of Freedom of Information requests received and Subject Access Requests up to the latest quarter 2022.

# 2.2 Background

Boards have one calendar month to respond to SARs and 20 working days to respond to FOIs. Numbers of both have increased in recent years.

## 2.3 Assessment

It is anticipated that requests for information to support Social Security payments will rise in 2022 following legislative changes. These will be routed through Data Protection but will require clinical staff to provide supporting information for payment applications. Response rates for Freedom of Information requests have generally been below target for the last 2 years, and we are looking at ways to improve the process.





## **SAR Request Activity**



Excluding requests for Covid-19 Vaccination information, there was a 57% increase in SARs received in 2021 compared to 2020, the second highest number received in one year. The first quarter of 2022 has seen a higher than average number received to date.



Recent legislative changes have given the Scottish Parliament powers over a number of Social Security benefits including Adult and Child Disability allowance.

The projected number of requests we might receive for information supporting applications for child and adult disability allowance in NHSWI, is estimated to be up to 500 requests per year.
