## Information for Patients

Approval process for NHS-funded escorts



Information for patients who are travelling for an appointment with regard to approval/funding of escorts

#### Introduction

In certain cases, patients travelling off island require an escort to accompany them.

The majority of Health Boards across Scotland only fund patient travel on a means tested basis, with only Boards covered by the Highlands and Islands Travel Scheme (Western Isles, Highland, Orkney and Shetland) providing financial assistance to patients and eligible escorts regardless of income.

The NHS Western Isles Patient Travel Policy sets out the criteria by which funding of escorts is approved - which is strictly based on clinical need.

### What does that mean in practice?

Under the NHS Western Isles system, GPs will provide clinical information to the Medical Director regarding escort requests, and the decision as to whether or not a funded escort is approved will be made via the Medical Director's office.

#### What if I need an escort?

It is important to stress that, where escorts are clinically required, we will continue to fund them in line with our policy. That has not changed.

However, we must ensure that the criteria are applied in a fair way. This will ensure that those patients who require an escort will continue to receive financial assistance, but it will also mean that those who do not meet the criteria will not receive NHS funding for an escort.

We understand and acknowledge that in some cases, this will be disappointing. However, there is a limited budget for patient travel, which is under significant pressure, and we must ensure that the money available is spent appropriately.

# What are the criteria that my application will be assessed against?

A summary of the criteria is below:

- 1. Patient is under 16 years of age.
- Patient has a Guardianship order or has an Incapacity Certificate or is a
  young person under the age of 26 who is Looked After. (An Incapacity
  Certificate is a certificate provided by a healthcare provider to allow
  treatment to be given for patients who are unable to make these decisions
  independently. Your main carer should be aware of this).
- Patient is undergoing a procedure that will require assistance on the return journey (e.g. major surgical procedure or joint replacement, medical therapy that causes significant side effects).
- 4. Patient has a significant physical or mental disability that would require assistance with travel (e.g. administration of medication by an escort, assistance with baggage, toileting etc. (although please note if a patient is able to travel with the support of airport ground crew/use of a taxi then an escort is not required).
- 5. Patient is attending an appointment that involves training in selfmanagement that a carer or relative will be undertaking on their return home.

(This list is not exhaustive and exceptional circumstances may also be considered. Social, emotional fear of flying or pregnancy are not considered reasons for a funded escort.)

# What if my request for an escort is declined and I am unhappy?

Patients have the opportunity to provide supplementary information in support of their application for a funded escort, should the funding have been initially declined. You can do this by contacting the Patient Travel office requesting a copy of the 'Further Information Form'.

If a request is declined, patients clearly still have the option of arranging to take an escort independently.
