2 Report summary

2.1 Situation

This report replaces the Chief Officer verbal update to the Board and provides information on key national and local developments that have a material interest for the IJB as a Public Body. The update reflects engagement with a number of Strategic partners, namely Scottish Government ministers and officials, COSLA, NHS Scotland and Health and Social Care Scotland (Chief Officers Professional Body).

2.2 Background

National HSCP Financial outlook

Following on from my update in March in which I shared the financial forecast for IJBs for 2025-26. The forecast was based on the financial position as projected (March 2025). Following the early projection further work has been undertaken nationally by IJB Chief Finance Officers which has given rise to a revised projection of an overall deficit of \pounds 497.5m set against a backdrop of diminishing reserves.

Given the gravity of the situation HSC Scotland has engaged directly with Cabinet Secretary, Ministers alongside key strategic partners with the aim of providing clarity and transparency of IJB finances and opening dialogue with regard to potential strategic choices and options.

Given the challenging nature of finances locally, particularly the depletion of reserves and the financial forecast for 2026-27 indicating a £5.3 million deficit, the IJB will be required to develop a sustainable financial strategy that is reflected in decisions on commissioned services going forwards.

NCS Advisory Board

Scottish Government has recently established an interim NCS Advisory Board. Whilst the current arrangements are for interim board, plans are to be developed for a full board through a fair appointment process.

The Board has a remit to:

- Advise Scottish Ministers, local councils, health boards and IJB's on improving delivery of social care support services, social work services and community health services
- Supports evidence-based, human rights-led service design
- Help shape policy and funding decisions

The early work of the Advisory Board is to focus on the production of National Care Service (NCS) Charter of Rights by February 2026.

Whilst the Board is initially established on an interim basis, during the early months, a fair and open appointments process will recruit an independent chair and individual members for the full Board to continue the work of the interim Board. The full Board will also include some members who have been nominated by organisations involved in the delivery of integrated health and social care services.

The current membership of the Board is included in the appendices of this report.

Programme for Government

The Programme for Government (PfG) was published on May 6th 2025. The programme focus on: eradicating child poverty, growing the economy, tackling the climate emergency, delivering high quality and sustainable public services.

Within the important work on delivering high quality sustainable public services there is an important commitment for the Western Isles, namely the development of the Barra and Vatersay Community Campus, a partnership between NHS WI, CnES and Scottish Futures Trust

(Programme for Government 2025 to 2026 - gov.scot)

Consultation – Integration Scheme

The Board approved the draft Integration Scheme in the last committee series. Legislation requires that the Scheme is published and is available for wider public consultation for a period of 6 weeks. A press release was published on June 6th inviting the community to feedback on the draft Scheme. The findings of the consultation will be reflected in the final draft for consideration by NHS WI Board and CnES Policy and Resources Committee.

The intention is to present the final draft to the IJB at the public series in September of this year before passing to Scottish Ministers for approval.

2.3 Assessment

As the IJB approached budget setting for 25-26 careful consideration will need to be given to strategic commissioning within the financial resources available. Our local position sees reserves being depleted at a time where the demand for services continues to grow as a direct result of our ageing demographic and the associated co-morbidities and polypharmacy.

Building on the most recent development session focusing on ethical commissioning the Board will be supported in key decisions with regard to commissioning and ensure that this links directly to outcomes within the financial resource available.
