PURPOSE OF REPORT:

To advise the Integration Joint Board of changes to its membership, including the Integration Joint Board Audit Committee.

1.1 This Report is concerned entirely with constitutional matters.

SUMMARY

- 2.1 Comhairle nan Eilean Siars Chief Executive, Mr. Malcolm Burr, confirmed their membership following the 2022 Council Elections held in May 2022. Confirmation of their appointed as Mr. Kenneth J. MacLean, Ms. Susan Thomson, Mr. Donald MacSween and Mr. Calum MacLean as substantive members of Curam is Slainte nan Eilean Siar with Mr. Paul Steele and Mr. Ducan MacInnes and two vacancies, as Depute/Proxy Members.
- 2.2 In June 2022 the IJB was also requested to make nominations to its Audit Sub Committee. The IJB is required to appoint two voting members from each of NHS Western Isles and the Comhairle and two other members. Membership is required to be updated to reflect those attending the meetings and the agreed position held within the Integration Joint Board and on the Integration Joint Board Audit Committee, as noted in the table at 2.3 of this report.
- 2.3 The report was presented to the Integration Joint Board on 30 June 2022, however the newly appointed Council voting members had not considered which person would become a member of the Audit Committee, as well as take on the role of Chair at the August meeting.

The Council voting members advised Mrs. McPhail in the evening of 30 June 2022 that Cllr. Susan Thomson and Cllr. Donald MacSween would be appointed to the IJB Audit Committee and that Cllr. Calum MacLean would take on the role of Chair of the IJB in August as part of the process of rotation for the role of Chair.

- b) the Integration Joint Board approves the Membership of its Intergration Joint Board Audit Committee from the Members noted in table 2.4, noting the requirement to appoint two voting members of each of NHS Western Isles and Comhairle nan Eilean Siar to its Audit Committee as well as two Non-Voting Members.
